

# Heat Pump Water Heater REBATE

Residential customers of the COOL SMART Program Sponsors can receive a \$750 Rebate if they have a licensed plumber install a qualified Heat Pump Water Heater when replacing an existing electric storage tank water heater or in the process of building a new home.

#### **REQUIRED STEPS TO RECEIVE YOUR REBATE:**

- Work with a licensed contractor to install a qualifying product at a property with an active residential electric account with one of the participating utilities or energy efficiency service providers.

4. Heat Pump Water Heaters are only eligible for financing when replacing an existing electric water heater

#### **ELIGIBILITY:**

Massachusetts residents who have an active, residential, electric account with one of the Program Sponsors listed below are eligible for this rebate when they:

- Replace an existing Electric Storage Tank Water Heater with a qualified Heat Pump Water Heater (Oil, Propane and Natural Gas water heater replacements are not eligible for this rebate)
- Install a qualified Heat Pump Water Heater in the construction of a new home.



#### WHAT IS A HEAT PUMP WATER HEATER?

A 'heat pump' is a device that moves heat from one place to another; it works much like an air conditioner or a refrigerator. While a refrigerator moves heat from your fridge to your kitchen, a heat pump water heater (HPWH) moves heat from your home into the hot water tank. Most HPWHs include an integrated hot water tank and a 'hybrid' mode (i.e. they can also run as standard electric water heaters if necessary).




#### IS IT RIGHT FOR YOU?

While HPWHs can certainly provide savings over standard electric water heaters, there are several other factors to consider before buying and installing.

#### Location

For the HPWH to run efficiently, the space should generally stay above 50°F.






#### Space

A heat pump removes heat from ambient air. Hence there must be a considerable volume of air available; most manufacturers recommend about 750 ft<sup>3</sup>. HPWHs often require larger clearances from walls so that air can circulate properly, and they are often taller and heavier than standard water heaters.

Most closets - even closets with louvered doors -are not appropriate for HPWHs.

Heat Pump Water Heater must be installed by a MA licensed contractor and/or plumber and installed within the MA electric service area of one of the participating sponsors, be UL listed, installed in accordance with the National Electric Code and manufacturer's specifications, and must conform to all applicable municipal, state and federal codes, standards and regulations, as well as program requirements. Must be ENERGY STAR qualified with an Energy Factor (EF)\* of 2.3 or greater and have a minimum 10 year manufacturer's warranty. Applicable only when replacing an existing electric storage tank water heater or in new construction. Rebate amount not to exceed the cost of equipment (excluding sales tax and all installation costs). Eligible heat pump water heaters can be found on www.MassSave.com/HPWH. Program is subject to change without prior notice, including rebate levels. Please note: Regulatory changes may impact rebate eligibility on tanks with a storage volume equal or greater than 55 gallons. \*Energy Factor (EF) is the ratio of useful energy output from a water heater to the total amount of energy delivered to the water heater. The higher the EF is, the more efficient the water heater.
